TERMS & CONDITIONS FOR FOREVER BUSINESS OWNERS

Right

Forever hereby grants the FBO a non-exclusive right, in any country, in accordance with the prevailing terms and conditions:

- to market and sell the products. This right only applies to products that the FBO is entitled to distribute under this Agreement.
 These products are ordered directly from Forever.
- To recruit/sponsor new FBOs in the countries in which Forever is represented in accordance with the prevailing rules in each country.

Terms & Conditions for FB0s

- The FBO is not authorized to represent Forever or bind it legally.
- This Agreement creates no legal relations other than a distribution agreement between Forever and the FBO. The FBO is at liberty to have more than one client.
- The FBO shall in other contacts with third parties that it is an Independent Forever Business Owner.
- The FBO is obliged to offer "potential FBOs" the opportunity to attend a business presentation before recruitment.
- The FBO decides the scope of his/her work input and working hours.
 The FBO is at liberty to engage assistants.
- The FBO is free to set its own prices, responsible for all selling expenses incurred and retains all surpluses from sales.
- The FBO always pays for all orders, including taxes, fees and freight in advance before delivery.
- The FBO undertakes to run the business in a lawful, ethical and moral way, to obtain all permits required by law, not to make any exaggerated, misleading or false claims about the products and

- Forever or Forever's bonus structure and not to do anything that could have a negative impact on Forever or any of its FBOs.
- The FBO has product liability him/herself in accordance with the legislation to sell products in sealed packaging with a best before date, for example.
- During the term of the Agreement and for twelve (12) months after that, the FBO may not be engaged in action which means that another FBO or Forever customer becomes a seller or equivalent in another Team/Network Marketing company (see also the direct selling association's code of conduct) or that another FBO ceases to be an FBO.
- Furthermore, during the term of the Agreement and after that the FBO may not attempt to build up or establish a business operation that could be detrimental to other FBOs, his/her team or Forever.
- The FBO shall otherwise follow the General Terms and Conditions.
- The FBO may cancel this agreement at any time, to apply from the point at which the written cancellation is received by Forever.

Terms & Conditions for Forever Living Products

- By signing this Agreement, Forever undertakes to supply products to the FBO and provide discounts and pay commission in accordance with the prevailing terms and conditions.
- In particular, it is Forever's duty to continuously inform the FBO of:
 - Forever's price policy and sales strategy.
 - Forever's delivery capacity if it is expected to fall below what Forever pledged or what the FBO may have expected for other reasons.
- Forever shall otherwise inform the FBO on an ongoing basis of circumstances that the FBO may be expected to have an interest in knowing.
- Forever shall otherwise follow the General Terms and Conditions.
- Forever applies self-billing.
- In addition to what has otherwise been provided for in this Agreement, Forever is entitled in accordance with that stated below to terminate this Agreement with immediate effect if any of the following occur:

- The FBO commits breach of contract.
- The FBO provides incorrect information about the field of application or effectiveness of Forever's products.
- The FBO provides incorrect information about how much a person can earn as an FBO for Forever.
- The FBO takes part in or is involved in action (directly or indirectly) that harms Forever's business or gives Forever or its Marketing Plan, bonus structure a bad reputation.
- Apply for bankruptcy, suspend payments, enter into composition proceedings, are granted or apply for company reorganization, prepare a balance sheet for liquidation purposes or are other wise considered to have become insolvent.

Other conditions

The parties may not transfer their rights and obligations as set out in this Agreement, with the exception of in the event of death or separation. This must be in accordance with the prevailing terms and conditions in each country.

Information in accordance with the Personal Data Act

Personal data about the FBO and/or the second-named person is collected and processed by Forever in connection with the application of this Agreement. The personal data is transferred to other companies within the Group to which Forever belongs and to business partners who handle payments, deliveries and travel bookings, etc. This means that your personal data is also transferred to countries outside of the EEA. To ensure that all personal data is handled in accordance with GDPR, we have drawn up data processor agreements with our external suppliers.
